Contact Information

January

Delinquent taxes assessed advertising fee.

February

Online auction.

May 1

Second half property taxes are delinquent at 5:00 PM

June

First delinquent tax notices sent to taxpayers. Investors may begin to sub-tax the current delinquent year.

November 1

First half taxes are delinquent at 5:00 PM for tax bills over \$100

December

Second delinquent tax notices sent to taxpayers for unpaid taxes.

December 31

Final day to pay full year taxes without interest if amount due is over \$100. Full year taxes at or under \$100 are delinquent after this date.

Final day to purchase sub-tax and assignments.

NOTE: If the delinquent date of any payment falls upon a Saturday, Sunday, or legal holiday, the payment filing shall be considered timely if performed on the next business day before 5:00 pm.

When making an inquiry on your property, please have your **PARCEL** or **ACCOUNT NUMBER** ready for our Customer Service Representatives. We also provide a variety of Parcel Information through our websites, Parcel Inquiry, and Tax Lien Web.

Annual Tax Extension Master

Sequence: **Parcel Number**

Contains "as-billed" data (conditions existing on a parcel at the time the tax statement was printed) for a tax year. Includes all information used to calculate taxes for a parcel: valuations, class codes, percentages, classifications, exemption status, tax rates and the calculated tax amounts.

Tax Extension Master – As Billed / Resolutions (Subscription)

Sequence: **Parcel Number**

Produced at the beginning of the tax year and updated after each phase of current tax resolutions (action on a parcel that will change or alter the tax in some way). Includes parcel number and tax amounts.

Weekly Activity Update (Subscription)

Sequence: **Parcel Number**

Contains all tax activity for the week including resolutions, CP buyer payments, current/back tax payments, redemptions, payment restores, and special district payments. Includes transaction date, tax and interest amounts.

Year-End Activity

Sequence: **Parcel Number and activity date**

Contains all tax activity for the tax year including resolutions, CP buyer payments, current/back tax payments, impounds and refunds. Includes transaction date, tax and interest amounts.

Annual Legal Description Master

Sequence: **Parcel Number**

Contains all the legal description of each parcel of property in Maricopa County.

Sequence: **Parcel Number**

Contains the name and address information for the owner of record of each parcel of property in Maricopa County. The owner of record address is not necessarily the property address (situs) address.

Sequence: **Parcel Number**
